CONDITIONS OF ENTRY

- All artists 18 years of age and over
- A non-refundable entry fee of \$25 must be paid alongside the submission form.
 - Entry fee can be paid by cheque, cash, or e-transfer to: info@vivavidaartgallery.com
- Multiple media accepted: Paintings, Sculpture, Mixed media, Pottery, Jewelry, Glass, Fibre
- Image files: JPEG files of work must be submitted. The resolution of the images should be no smaller than 300 x 300 px, and be no larger than 5MB. Should you not be able to provide quality images, the gallery will offer photographic services, at a fee of \$5 per artwork.
- Each submitted artwork should not exceed the dimensions of 18" by 18" or any variation of these dimensions. It is encouraged to have a variety of sizes and prices
- The jurors and staff of Viva Vida Art Gallery reserve the right to refuse any or all entries because of suitability for the show, quality or the artwork, excessive size, complexity, special conditions of installation or if the work does not contain the same qualities as the submitted image.
- Entry Forms must be complete and received with entry fee and images of artwork by **November 21st, 2025**
- By submitting artwork to this call, artists agree to allow Viva Vida Art Gallery to negotiate a sale on their behalf including up to 10% off of the artist's submitted sale price. Following a sale, payment to artists will be made by cheque within 30 days. **COMMISSION RATE: 50%** to artists, 50% to Viva Vida Art Gallery.
- Art works must have been completed within the last four years.
- All entries must be of original design and personal execution.
- All work must be received installation ready with appropriate hanging device and/or installation instructions, and must be clearly labeled with the artist's name and title of work.
- Accepted work may not be withdrawn before the close of the exhibition: January 18th, 2025.
- Viva Vida does not provide insurance for artwork. Artists are responsible for arranging their own insurance during transit and exhibition.
- Transport from gallery to client will be handled by the gallery.
- The cost of shipping artworks to, and from the gallery are the responsibility of the artist. If shipped, the artist can provide a return, prepaid waybill in their delivery shipment for the return of artwork.
- Viva Vida Art Gallery reserves the right to photograph and reproduce images from the exhibit for promotional purposes
